

EC2U Joint Master's LIFELINE – Lifelong Well-Being and Healthy Ageing

Informative Note on the Student Fees

1. General Fee Structure

Fees are payable on a semester basis to the Partner University where the student is completing 30 ECTS credits.

What is included in the EC2U Student Fees:

- Tuition fees and mandatory local administrative fees
- Legal liability insurance
- Library and laboratory access costs
- Any other mandatory cost related to the participation in the Degree Programme (for the standard duration)
- Administrative and organisational support
- Enrolment costs

What is NOT included:

- Specific diploma issuance fees (where locally required)
- Accommodation and subsistence (living expenses)
- Comprehensive health insurance
- Travel expenses to and from Partner Universities
- Visa, passport, and document legalisation costs
- Any costs incurred beyond the standard duration of the Degree Programme

Financial regulations:

- Financial support may be available from Partner Universities based on their respective regulations. Detailed information will be provided in the application form.
- Please note that local fee amounts are subject to slight adjustments based on updated local regulations.
- Students who withdraw from the programme are not entitled to a reimbursement of fees already paid.
- Fees collected locally must be paid in full for the academic year, even if the student spends only one semester at that specific institution.

Institutional specifics:

- University of Turku: Local fees are mandatory for the semester(s) spent in Turku, upon graduation from the university, and when receiving an Erasmus+ mobility grant from Turku.
- University of Jena: Students must pay the full local fee starting from their first mobility in Jena. To obtain a diploma from Jena, students must remain enrolled and pay a reduced semester contribution even when studying at another EC2U University. An additional €20 fee applies for the "thoska" student card. See past fees [here](#).
- University of Coimbra: Students pay a standard reference amount of €750 per year plus a €20 registration fee (includes mandatory school insurance under Portuguese law). The University of Coimbra is in the process of standardising a common model for EC2U Masters according to the general rules approved in the EC2U Alliance, and still requires approval from the university bodies. Until that approval, UC will only accept EU students.
